



APPLICATION TO UNPOOL TWE

When do I use this form?

Use this form when you “**UNPOOL**” (separate) one or more Transferable Water Entitlements (TWE's). When you do this the shares allocated to the Pooled identity will revert back to the original TWE ownership / tenancy. This will be your “*Notice to Unpool*” to Harvey Water.

Why do I need to fill out this form?

Harvey Water needs to know who its customers are at all times and who has the rights to receive water.

This form provides Harvey Water with information that:

- You want to “unpool” your TWE
- You have the authority to carry out these transactions
- There are no impediments to the “unpooling” which Harvey Water should know about.

Is there anything else I should know?

- All parties which agreed to the pooling must agree to “unpool” the TWE
- TWE cannot be unpooled if there are any outstanding fixed or consumption charges owed to Harvey Water by the Pooled TWE
- All future water consumption charges and fixed charges for the unpooled TWE will be the responsibility of the original owner of the TWE
- You can organise your pooling in a different way if you wish
- **An administrative fee of \$15.00 must be lodged along with the application form**
